With reference to your request for Extension of Provisional Recognition on the subject cited above, I am directed to convey the approval of Director (Education) for Extension of Provisional recognition from class Pre-primary to Secondary level w.e.f. 01.04.2020 to 31.03.2028 along with the grant of extension of provisional upgradation from Secondary to Sr. Secondary level (Arts & Commerce streams) w.e.f. 01.04.2023 to 31.03.2028 subject to the following terms and conditions:-

1. Final outcome of the notification order from MoUD, Govt. of India.
2. That the school observe all the relevant provisions of RTE Act 2009, DSEAR, 1973 and Directions/Instructions issued by the department from time to time.
3. That the school shall comply with the orders dated 07.11.2007/guidelines of DoE and judicial pronouncements w.r.t. safety of the students and shall take all necessary steps to this effect.
4. That the school shall comply with the provisions of section 10(1) read with rule 125 of DSEAR, 1973.
5. That the school shall submit the latest copy of fire safety certificate issued by DFS within 02 months to the district authority.
6. That the school shall comply with clause 14 of order No.F.DE/15 (56)/ACT/2009778 dated 11.02.2009 in r/o maintenance of DRF. School shall also follow FN-21 'Accounting by schools' as issued by the institute of Chartered Accountants of India (ICAI) for proper accounting treatment.
7. That the school shall make payment of salary and other admissible allowances to its teaching/non-teaching staff as per ongoing CPC through Bank/RTGS and submit the compliance within 02 months to the district authority.
8. That the school shall submit the latest copy of water test report issued by DJB within 02 months to the district authority.
9. That the school shall submit the latest copy of School Health Certificate issued by MCD within 02 months to the district authority.
10. That the school shall comply with the order F.No.DE.15 (305)/PSB/Misc./2020/Pt.File-11/5658-5662 dated 21.06.2023 with regard to appointment of special educator.
